Participation of LLPI, sponsored SMEs and Country Unit Representatives at the AALF, 6th Edition and Related Events

February 20 – 22, 2013 Millennium Hall Addis Ababa, Ethiopia

I. Introduction

- 1. COMESA/LLPI co-sponsored and co-organized the 6th Edition of All African Leather Fair (AALF), 2013, which was held at the Millennium Hall, Addis Ababa, Ethiopia, from 20 22 February 2013.
- 2. The other co-sponsors and co-organizers of the event where: the Ethiopian Ministry of Industry (MoI), the Ethiopian Leather Industry Development Institute (LIDI), UNDP, UNDO, the Ethiopian Shipping and Logistic Services Enterprise, Awash International Bank S.C. Modern Group and Jupiter International Hotel. The Ethiopian Leather Industries Association (ELIA) is the lead organizer of the AALF...
- 3. The 6th Edition of AALF was officially opened by H.E. Mr. Hailemariam Desalegn, Prime Minister of the Federal Democratic Republic of Ethiopia. He was accompanied by H.E. Mr. Mekonnen Manyazewal, Minister of Industry and other high ranking Government officials, members of Diplomatic corps, LLPI Senior Management members, International Organizations and influential partners in the leather industry.
- 4. The 6th Edition, AALF 2013 attracted a significant number of producers and buyers of leather and leather products as well as influential investors from various countries. A total of 154 exhibitors, this included 57 international enterprises, 15 countries units and 21 SMEs drawn from the COMESA region. The balance was made up of Ethiopian enterprises.
- Despite all the efforts made by the management of LLPI to bring together all Country Units and SMEs representatives of Member States, Eritrea did not send its delegates to participate in the Event and attend other subsequent programmes.

- 12. The Guest of Honor, Prime Minister of the Federal Democratic Republic of Ethiopia, Ambassadors, high-ranking Government Officials and renowned entrepreneurs visited the COMESA/LLPI/RISP Pavilion during the official opening.
- 13. Most of the SMEs sold out most of the products, which they had brought for showcasing, which demonstrates the high quality of their products, in face of competition from products from the host country, which is one of the leading giants in the COMESA region in the production of leather and leather products.

Small and Medium Scale Enterprises (SMEs)

14. The COMESA/LLPI /RISP programme sponsored the participation of 21 private entrepreneurs from Ethiopia, Kenya, Malawi, Rwanda, Sudan, Uganda, Zambia and Zimbabwe, whose combined stand occupied the major portion of one block. These were sponsored under a cost sharing scheme. The cost sharing scheme is meant to build sustainability and a non dependency syndrome among the SMEs.

15. Recognizing the importance of the Fair, which has evolved into an annual event, COMESA/RISP sponsored (transportation and stand fees) for 21 selected SMEs representatives drawn from 8 Member States. - 16. A one day Awareness Creation Workshop, facilitated by COMESA/LLPI and sponsored by the COMESA/LLPI/RISP was held at the Ambassador Hotel, Addis Ababa on 22nd February 2013.
- 17. 31 participants drawn from 8 COMESA Member States (Ethiopia, Kenya, Malawi, Rwanda, Sudan, Uganda, Zambia Zimbabwe and LLPI attended the Awareness Creation Workshop). The Director, LLPI, Dr. M. Mwinyihija welcomed the participants and made opening statements.
- 18. The workshop was aimed to discuss substantive issues impacting on the leather sector with the Core Team members and SMEs who were participating in the AALF.

- 21. The Agenda Items discussed during the meeting included the followings:
 - Adoption of the Minutes of 5th Core Team Meeting,
 - Matter Arising from Minutes of the 4th Meeting
 - Review of Activities since 5th Core Team meeting, Closure of PACT II
 - Envisaged Successor Programme
 - Identification and approval of New Core Team Members.
 - Way Forward for the Core Team
 - Any Other Business.
- 22. The opening session consisted of welcoming statements by Dr. M. Mwinyihija, the COMESA/LLPI Director. He stressed the need of strengthening the Regional Leather Sector Core Team by making sure that its composition is dominated more by the private sector to the magnitude of a minimum limit of 75%. He further pointed out that it was fundamental that the core team is well resourced, as its functions were pivotal in supporting the implementation of the regional leather value chain.
- 23. Participants noted that there was a need to address the following issues, which were impacting negatively on the performance of the regional value:
 - Increased imports of second hand and synthetic footwear and leather products from the third party countries;
 - b. Shortage of finished leather in most Member States because of large export of raw hides and skins and wet blue;
 - c. Ethiopia's non FTA status was impacting negatively on intra trade of leather and leather products from Ethiopia;

- d. Shortage of suitable finance instruments to support the development of value addition and SMEs
- e. The need to boost the capacity building in the areas of design, technical supervision, production and quality control; and
- f. They also recognized the support that COMESA was extending them to permit them to participate in international fair, as it was helping to improve their exposure and also to create linkages with potential suppliers and buyers.
- 24. In line with the Secretary General of COMESA directive to strengthen the Core Team, six (all private entrepreneurs) new Core Team members and 9 observers were identified and approved unanimously by the meeting:

- 25. The 6th Core Team Meeting noted that the budget for subsequent meetings of the Core Team was secured under Regional Integration support Program (RISP).
- 26. The Meeting recommended that the 7th Core Team meeting be held in Khartoum, Sudan, between June July 2013. The Core Team directed the Secretariat to take all necessary measures and to ensure that the above new members and observers attend the 7th Core Team Meeting.

VIII. Recommendations

- 28. The All African Leather Fair, 6th Edition, 2013 lacked sufficient organizational capacity and therefore, it is recommended that all AALF Editions are supported by experienced and professional Event Organizers or Consultancy Firm to guarantor full primary and secondary support for exhibition, expos and other events.
- 29. Full sponsorship by financing organizations may lead African entrepreneurs to develop a dependency syndrome, hence there is a need to cultivate a self-sustenance model through a phased out cost sharing process. Sponsorship should be an optional to African SMEs who want to further their businesses.
- 30. The AALF Events must cover the whole value chain i.e. importers and exporters of finished leather, producers and traders of chemicals, tanning and footwear machineries.
- 31. The venue must be provided with services such as Government Agencies, Business Centers, B2B/B2C, Portal and Virtual Event Services, Exporters and Foreign Buyers Advice Bureau, Foreign Visitors Bureaus, General Information Center, Press Room (Press Conferences), Internet Access etc.
